All MSA Members (Voting and Non-voting – Associate) are entitled to attend the AGM and to be heard, but only the Voting Members (Leagues/Region) may vote via their corresponding appointed Delegates.

The list of non-voting and voting Member Delegates will need to be submitted before the AGM.

Although the meeting is in person, electronic platforms will be made available for the AGM.

**IMPORTANT:** Voting Members must inform the MSA of the names and e-mail addresses of the Voting Member Delegates by submitting a completed attached AGM Delegate Registration Form on or before **October 20, 2023** (MSA By-Law Article 3.12).
